TRANSPORT ORDER
OBLIGATIONS OF THE PARTIES

11. Obligations of the parties:

11.1. Obligations of the Customer:

1. Present the cargo described in the order, load within 24 and unload 48 in hours.
2. To control loading and fixing of the cargo, to check if the package is in order, to control the axle load capacity.
3. To provide with the documents and certificates escorting the cargo which conform to the requirements of the freight shipping on international routes.
4. To ensure the requirements for cargo marking and packaging regulations.
5. To pay a detention fine of 100 EUR per day in the event of the customer's failure.
6. In the event of delivery failure, to pay the "Carrier" a fine of 10% off the freight sum.

11.2. Obligations of the Carrier:

1. To deliver technically orderly rolling-stock to the loading points and to ensure its appropriateness for transportation of the requested cargo.
2. To receive the necessary insurances, licenses and other documentation enabling and obligatory for the transportation.
3. To control loading and fixing of the cargo, to check if the package is in order, to control the axle load capacity.
4. To ensure that the carrier observed the procedures and regulations of freight shipping, the execution of shipping documentation and cargo declaration, the legislation and regulations in force, the Regulations for International Cargo Transportation by Road, the Regulations for Provisions of Work of Crews of Vehicles Engaged in International Road Transport, the Geneva Convention of 19 May 1956 on the Contract for the International Carriage of Goods by Road, and other requirements of normative documents regulating freight shipping on international routes.
5. To assume full material responsibility for the loss, lack or damage of the received cargo to be delivered, and make amends for the "Customer".
6. In the event of failure to provide a vehicle, to pay the "Customer" a fine of 10% off the freight sum.
7. To pay a detention fine of 100 EUR for each day.
